The legal voters of the Wolcott Town School District are hereby notified and warned to meet online via google meeting, February 24th, 2022 at 6:00 PM. The assembled meeting shall constitute the **Public Informational Meeting for discussion on the proposed FY23 school district budget** as required by Title 17 VSA 2680 (g).

**Article 1:** To elect the following school district officers for the ensuing year:

- School District Meeting Moderator
- District Clerk
- District Treasurer
- Alternate District Treasurer

**Article 2:** To elect all necessary School Board Directors as required by law:

- School District Director for a term of two years
- School District Director for a term of three years
- School District Director for a term of one year remaining on a two year term

**Article 3:** To see if the voters of the school district will authorize the following salaries to be paid for the officers and directors of the school district:

School Board Chair	\$ 000.00/ yr	District Treasurer	\$ 850.00 / yr
School Board Member	\$ 000.00/ yr	Alternate District Treasurer	\$ 25.00/pay per needed
		District Clerk	\$ 000.00 / yr


**Article 4:** Shall the voters of the school district approve the school board to expend \$5,037,894 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$18,934 per equalized pupil. This projected spending per equalized pupil is 5.97% higher than spending for the current year.


**Article 5:** To see if the voters of the town will authorize the school board to borrow money in anticipation of state revenues.

Voting on the aforementioned Article 1-5 will be by Australian Ballot at the Wolcott Town Offices on Tuesday, March 1, 2022 between the hours of 8:00 a.m. at which time the polls will open, and 7:00 p.m. at which time the polls will close. The legal voters of the Wolcott Town School District are further notified that voter qualification, registration and absentee voting relative to said meeting shall be as provided in Chapter 43 of Title 17, Vermont Statutes annotated.
