to be held March 5, 2024

The legal voters of the Town of Wolcott, Vermont are hereby to meet at the Wolcott Elementary School in said Town on March 5, 2024 at nine o'clock in the forenoon to act upon the following articles of business:

Article 1. Shall the voters appropriate \$ 19,942 to the following social service agencies, pursuant to 24 V.S.A. § 2691?

Article 2. Shall the voters authorize payment of real property taxes to the Town Treasurer in two equal installments; with delinquent taxes having charged against them three percent (3%) penalty 1-5 days late, five percent (5%) penalty 5-10 days late, eight percent (8%) penalty after 10 days late and collect interest on late and delinquent payments of one (1%) percent per month for the first three months and one and half (1 ½%) thereafter (32 VSA 4873 & 5136 (a) ?

First installment to be paid on or before November 15, 2024

Second installment to be paid on or before
(32 VSA § 4871)

May 15, 2025






Article 3. Shall the voters of the town vote to adopt the proposed Selectboard budget in the amount of \$1,745,208.88 , less anticipated revenues in the amount of \$ 394,982.00 leaving a portion thereof in the amount of \$1,350,226.88 to be raised by taxes.

Article 4 to be voted on by Australian Ballot at the Wolcott Elementary School between the hours of 8:00 am at which time the polls will be open and 7:00 pm at which time the polls will close. The legal voters are hereby further notified that voter qualification, registration and absentee voting relative to said meeting shall be provided in Chapter 43 of Title 17, V S A. The following articles will be voted by Australian Ballot:
